## PROTOCOL

It is important for me to acknowledge the contributions of various committed and diligent staff that have worked largely behind the scene to make this programme the success it has been. Permit me to use this opportunity to thank the Acting Director General, Bureau of Public Service Reforms (BPSR), his team and our development partners, DFID-Partnership to Engage, Reform and Learn (PERL) for their continued and steadfast support to the Federal Public Service reform programme, which I urge them to sustain.
