

**REVISED FREQUENCY OF MEETINGS FOR PART-TIME MEMBERS OF
GOVERNMENT COMMITTEES, BOARDS OF FEDERAL AGENCIES,
STATUTORY CORPORATIONS AND GOVERNMENT-OWNED COMPANIES**

As part of Federal Government's measures to reduce the cost of governance in order to make more funds available for priority projects, Government has approved the review of the frequency of meetings for Part-time Chairmen and Members of Committees, Boards of Statutory Corporation, Agencies and Government-Owned Companies. The revised

frequency of meetings and the applicable sitting allowances which take effect from 1st April 2016 are as follows:

2. It should be noted that Chief Executive Officers and other Public Servants on monthly salary who are board members in their own establishments are not entitled to sitting allowance. It should also be noted that a sitting may comprise more than one meeting.
