## PREREQUISITES FOR THE IMPLEMENTATION OF INFORMATION TECHNOLOGY PROJECTS IN MINISTRIES, DEPARTMENTS, AGENCIES AND GOVERNMENT OWNED COMPANIES

The Federal Government has observed with dismay the indifferent compliance levels by Ministries, Departments, Agencies and other Government establishments with extant regulations issued to guide the implementation of Information Technology (IT) Projects as well as the procurement of Locally Assembled IT Components.

- 2. These policy directives were issued to ensure that the technology and services being procured are suitable for the country from the point of view of national security and the environment and the attainment of the following objectives amongst others:
- i. facilitate alignment of IT projects /investments with MDAs and other government establishments mandates and functions with the overall IT vision and policy of the Federal Government;
- ii. facilitate the integration of IT systems and services to save costs, promote shared services, interoperability and improve efficiency;
- iii. ensuring transparency in IT procurement by MDAs and other government establishments
- iv. ensure adequate arrangements are in place for indigenous capacity for aftersales-service to sustain the project beyond the initial deployment;
- v. ensure that the project promotes indigenous content and preference is given to indigenous companies where capacity or the product or service exists and comparable to other brands in terms of best practices and quality etc.
- 2. It was in realization of the above objectives that the National Information Technology Development Agency (NITDA) was designated as the Federal Government clearing house and certifying authority on all Information Technology projects and procurement of IT components.
- 3. It has therefore become necessary to reiterate that all extant regulations guiding the implementation of Information Technology (IT) Projects as well as the procurement of Locally Assembled IT Components still subsists and are enforceable. In this regard, the provisions of the relevant extant Circulars are referenced in the table below for emphasis:

- 4. For the avoidance of doubt, MDAs and other government establishments are to relate with and obtain prior approval from NITDA for the implementation of Information Technology (IT) Projects as well as the procurement of Locally Assembled IT Components.
- 5. The implementation of this circular is with immediate effect and the contents should be brought to the attention of all Agencies of Government for strict compliance as future non-compliance would be considered a violation, which will be appropriately sanctioned.
