THE NEED FOR ADHERENCE TO GUIDELINES ON THE REFORM AND RESTRUCTURING OF MINISTRIES, DEPARTMENTS AND AGENCIES

I write to invite the attention of all Ministries, Departments and Agencies (MDAs) to the extant Guidelines for the Reform and Restructuring of Ministries, Departments and Agencies (MDAs) which provide the framework for the implementation of Reform Programmes in all MDAs so as to have a seamless reform process and avoid possible functional overlaps among the MDAs.

2. Pursuant to the foregoing, it is relevant to indicate that a most effective and strategic approach to successful implementation of reform programme is to allow each Ministry, Department or Agency, rather than external Consultants, to initiate its reform programme, based on its core mandate. Furthermore, the governance framework and the process for supervising the

reform and restructuring of MDAs is to be led by a Reform Committee structure under the technical guidance of the Bureau of Public Service Reforms, while the Federal Executive retains the ultimate responsibility for approval.

- 3. Accordingly, any Ministry that is desirous to undertake a reform or restructuring is required to constitute a Ministerial Reform Committee to be headed by the Permanent Secretary with the Director of Reform Coordination of the Ministry as Secretary. The Committee should also representatives of the Office of the Secretary to the Government of the Federation (OSGF), Office of the Head of the Civil Service of the Federation (OHCSF) and the Bureau of Public Service Reforms (BPSR) as members. In particular, the Bureau of Public Service Reforms is at all times available to provide the required technical support to the Committee, and all reforming MDAs are advised to liaise effectively and regularly with the Bureau in all the stages of the reform process. In this regard, the relevant documents which guide reform processes; namely, the Guiding Principles for Merging and Restructuring of MDAs and the Generic Guidelines for the Reform of MDAs in the Federal Civil Service are available for collection from the BPSR.
- 4. For the avoidance of doubt, I wish to emphasize that the report of the Ministerial Reform Committee will require the approval of the Federal Executive Council before implementation.
- 5. Kindly ensure strict compliance with the content of this Circular.
