## REQUEST FOR INFORMATION ON RECRUITMENT BY FEDERAL GOVERNMENT MINISTRIES, DEPARTMENTS AND AGENCIES IN 2016

It has been brought to the attention of Mr. President that some Government Ministries, Departments and Agencies recruited staff in 2016 without obtaining the required approvals and/or adhering to established procedures as prescribed in their respective enabling laws.

- 2. Accordingly, Mr. President has directed the Office of the Secretary to the Government of the Federation (OSGF) to:
  - a) Identify the Agencies that have recruited in 2016;
  - b) Review the documentation relating to the recruitments to confirm if proper due process and approval procedures have been followed; and
  - c) For agencies that have not complied with due process or do not have the necessary approvals, submit recommendation of the most appropriate

sanctions to the responsible individuals for Mr. President's kind consideration.

- 3. Pursuant to the foregoing directive of the President, you are requested to inform all the Agencies under your supervision to forward the list of Officers/Staff they recruited in 2016, including the relevant supporting documents on the recruitment exercise to the Office of the Secretary to the Government of the Federation on or before **27**<sup>th</sup> May, **2017**.
- 4. All Ministries, Departments and Agencies are to comply with this Circular and adhere to the deadline for the submission of the information required. Permanent Secretaries are particularly advised to inform the Agencies under their supervision for timely compliance.
- 5. Please bring the contents of this circular to the attention of all concerned for their information and compliance.
